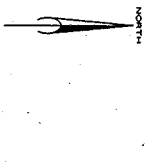


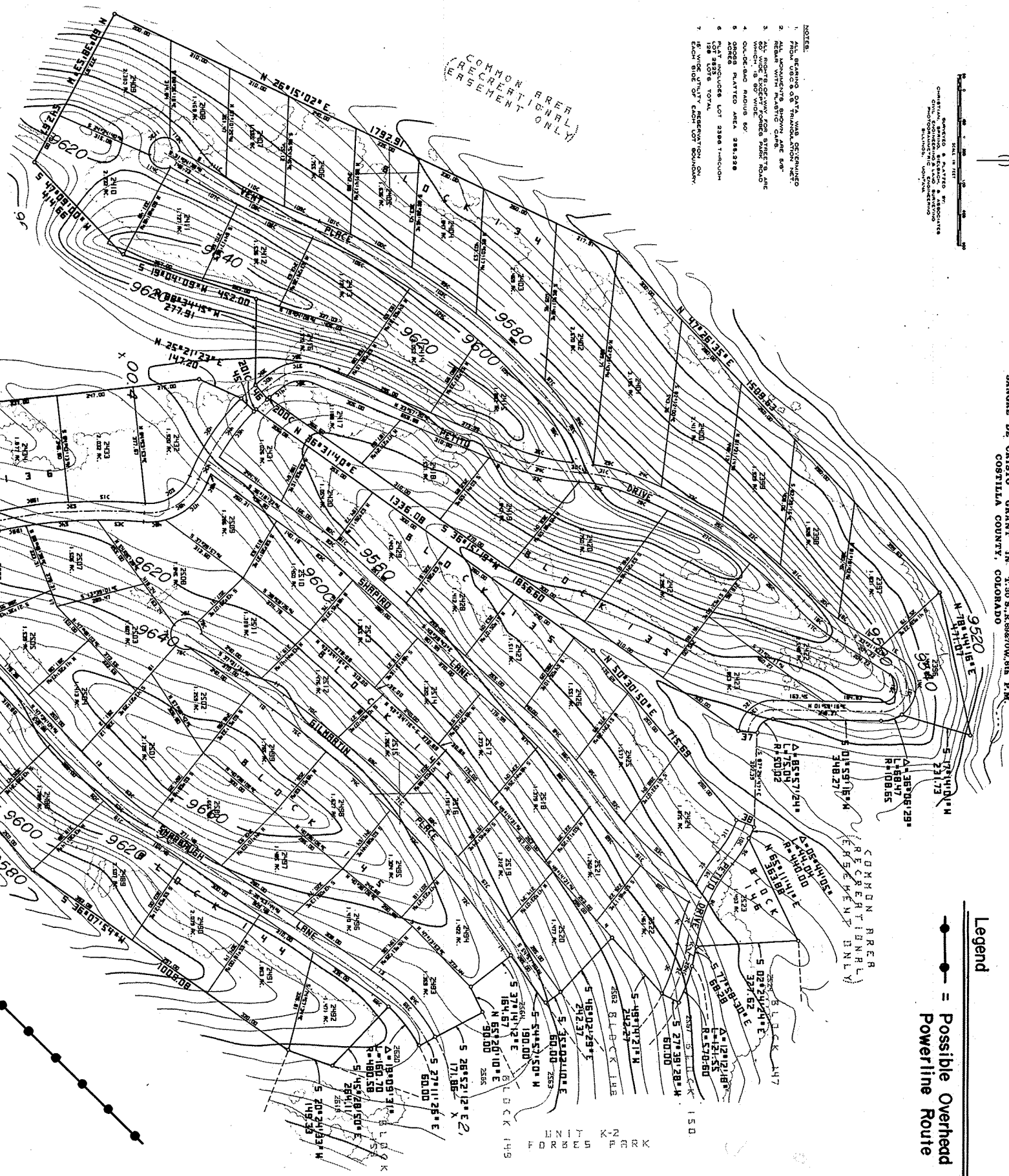
UNIT K-1, SUBDIVISION

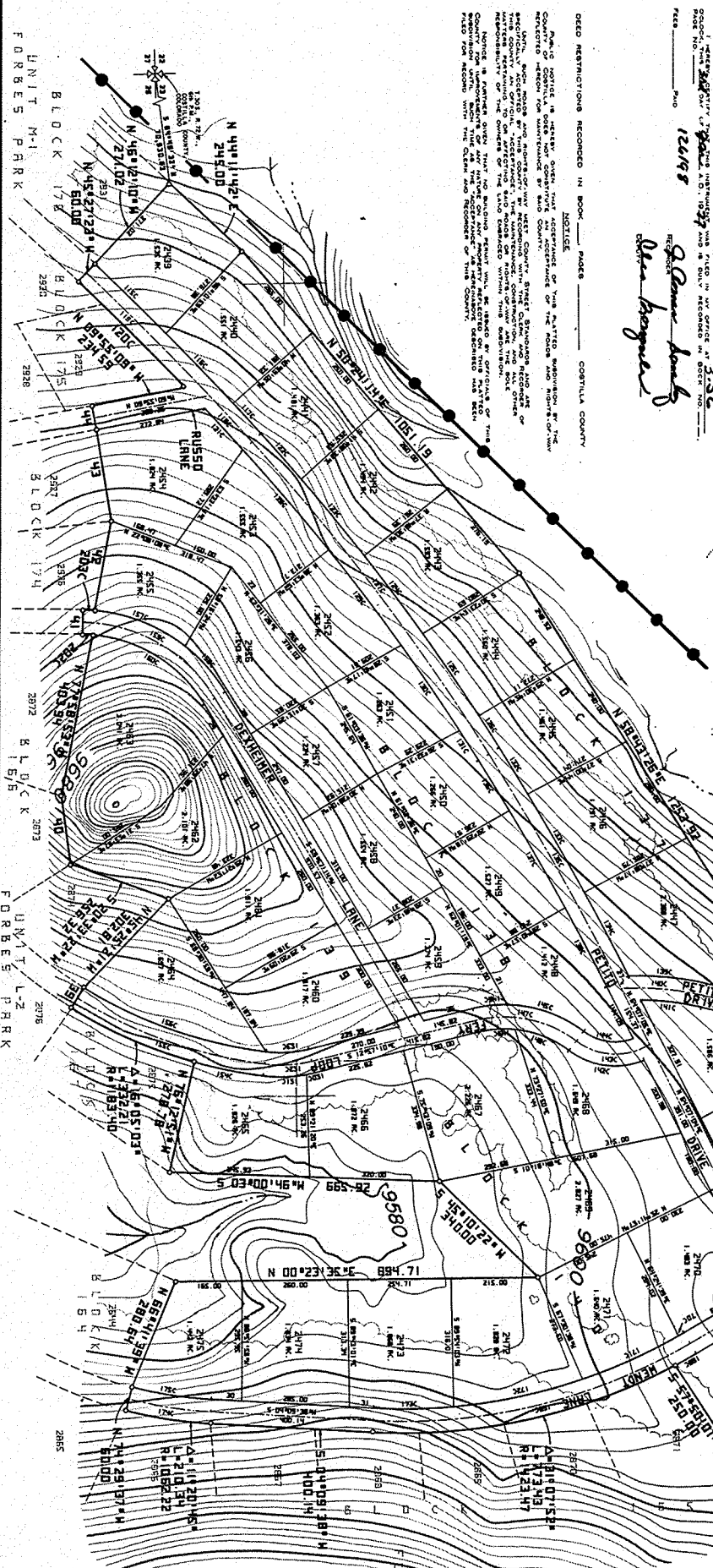
